

Parade of Homes Rules and Regulations for 2025 FALL Parade of Homes Application – WHBA

NOVEMBER 6-9, 2026

Friday 5pm – 8pm, Saturday & Sunday 11am – 4pm

PARTICIPATION FOR WHBA PARADE OF HOMES:

- Entry is limited to 3 homes/residential units per WHBA Builder Member. The Builder Member must act as the general contractor of the Parade of Homes units.
- Participant must sign and initial Parade of Homes Builder Contract, agreeing to abide by the Parade of Homes Builder Contract. Appropriate entry fee and required documents must accompany the signed and initial agreement per contract dates. The Parade Chairpersons will review and initial each submitted Parade Builder Contract.
- Parade homes must be newly constructed and haven't been entered in any prior WHBA Parade of Homes.
- For Remodelers: The remodeler member must also be the general contractor on the project. Projects must be either a substantial addition/or interior remodeling with a contract price minimum of \$50,000 for the interior portion of the home. All exterior-only projects are excluded.
- Builder must be licensed as a residential contractor by the State of Wisconsin and provide proof of general liability Insurance.
- To participate in the Parade, the builder applicant must be a member of WHBA (\$550) when contracts are due. (no waiting period)
- The builder must attend the mandatory Parade of Homes builder meeting
- The building permit must be in the name of the builder.

SALE OF HOME

The home may be sold at any time; however, homes **may only be occupied with the approval of WHBA Parade Committee Chair, and builder/homeowner agreement (supplied by WHBA) submitted to the WHBA Office.** If the home is occupied without prior approval from the Committee Chair and a signed Homeowners Agreement, the Parade Builder Member will be fined \$1500, and the home may be disqualified, which will result in a forfeiture of the entire Entry Fee and any expenses that have accrued. Remodel entries are exempt from this rule.

OPEN HOUSES

Parade entries shall have **NO** publicly advertised open houses within **15** days of the Parade start date. Before Parade dates, no mention of "Parade Home" may be made - private showings are encouraged.

A violation of the open house rule, the Parade Builder Member will be assessed a \$1000 fine.

MEDIA ADVERTISING

- Listing in the MLS is permitted.
- Advertising Parade homes events in media such as newspaper, radio, television, social media, etc., IS permitted and highly recommended.
- Advertising the Parade home is encouraged DURING the Parade of Homes; however, the advertisement must not include any other home(s) that are not part of the Parade of Homes.
- Builder Member will be accountable for all listings/advertisements of the parade home, even if the agent of Builder Member did the listing. Violations of media advertising rules will result in a fine of \$1000.
- Real estate agents or brokers working at the Parade home may not promote any projects or real estate that the Builder Member is not directly involved with, including developments, subdivisions, MLS listings, etc.

NON-COMPLIANCE APPEALS

Parade Builder Members have the right to appeal to the WHBA Board of Directors for any non-compliance decisions made by the Parade of Homes Committees as to participation in the Parade, entry fees withheld, or fines assessed. The appeal must be made to the WHBA Board in writing. The WHBA Board of Directors shall make the final decision on all matters of general policy of the Parade.

INDEMNIFICATION

Indemnification. Builder hereby represents and warrants that Builder is the owner or licensee of the Materials and that Builder has the right and/or license to provide the Materials to WHBA for use before, during, and after the event as set forth herein. Further, notwithstanding any other provision of this agreement, Builder hereby agrees to hold harmless and indemnify WHBA from any and all third-party claims, demands, fees, and costs (including reasonable attorney fees) associated with the use of the Materials used by WHBA in relation to the event.

VIRTUAL TOUR

Photo Appointment Cancellation. If a scheduled photography appointment isn't cancelled or rescheduled at least twenty-four (24) hours in advance of the scheduled time, Builder agrees to pay a \$900 cancellation fee. This fee also applies if a Builder fails to show up to a scheduled appointment or if the home is not properly prepared or suitable for a photo shoot. Any Parade Home may be photographed and used for promotion by the Parade of Homes committee without further written permission from the participants.

TICKETS

The admission fee to view the Parade of Homes will be \$10 at the door; kids are free. Tickets will also be sold online for approx Six weeks prior and the duration of the Parade of Homes event for \$8. Each builder can purchase tickets for \$5. Parade participants are responsible for selling tickets as well as recording ticket sales and attendance. Failure to do so will result in a fine of \$1500.

RESPONSIBILITY

- **The Builder member is required to secure up to 4 advertisers for the page opposite their rendering, (builder), page(s). If ads are not filled by builder by the due date, the builder will be assessed a \$1500 charge per page for the Association to fill each page(s).**
- Staffing at the Parade house. (Ticket sales)
- There shall be no mandatory lotteries, mandatory guest list registering, or mandatory contests held in conjunction with the WHBA Parade home. WHBA has the sole right to decide on any promotional items during the event. Feel free to hold a contest, it just cannot be mandatory.
- The Builder Member agrees to accept the sole responsibility for the security of the home, both during construction and during the Parade of Homes. WHBA is not responsible for any damage or issues at the parade home.

COMPLETION/INSPECTION REQUIREMENTS

- It is the Builder Member's responsibility to submit a key or lockbox number to the Association office no later than Friday, **October 25th, 2026**. By signing and initialing this Builder Contract, the Builder Member indicates his/her willingness to comply with the attached rules and regulations and the entire Builder Contract.
- **All homes must be completed and ready for inspections by NOON on the Tuesday of the week BEFORE THE parade. The Builder member will not be allowed to open until inspection is completed and passed.**
- The Inspection Committee shall be made up of members of another HBA and/or members of WHBA as appointed by the Parade of Homes Chairperson.
- If the Inspection Committee is unable to enter the home, or if the home is not "tour-ready" and safe for showing as of the inspection date, the Builder Member will be offered the opportunity for re-inspection. A fine of \$200 may be applied to homes requiring re-inspection. Builder Member will be responsible for contacting Parade of Homes Chairperson to arrange for re-inspection by 4:00 p.m. on the Wednesday of the week of the parade, to arrange re-inspection, which is to be completed no later than Noon on the Thursday of the week of the parade. If the home is tour-ready and safe at re-inspection, it will be allowed to open. If the home is not tour-ready and safe on re-inspection, it will not be open, and forfeiture of the entire entry fee plus any expenses or fines that have accrued.
- Remodeler may choose to unlock the job for inspectors or make other arrangements for inspectors, but cannot impede or delay the Inspection Committee's ability to enter the home.

WITHDRAW

In the event a Builder member wishes to withdraw from the Parade of Homes, written notice must be submitted during regular business hours to the Executive Officer of WHBA via email at jodi@whba.net.

Withdrawals submitted on or before **September 15, 2026**, will incur a **\$1,200 penalty**. Any withdrawals submitted **after September 15, 2026**, will result in the **forfeiture of the full entry fee**, in addition to any **accrued expenses or fines**.
